Announcements

- MCDOT provided information to an inquiry raised at the September 28, 2022, Taxicab Services Commission meeting regarding changes to Senate Bill 868, the enabling legislation for the County's Transportation Services Improvement Fund.
- Commission members present discussed strategies to engage staff with the Office of Intergovernmental Affairs, and the Maryland General Assembly, on increasing the amount counties are allowed to charge as a surcharge for using a Transportation Network Company (TNC) such as Uber or Lyft.

Discussion Items:

Ride-on Reimagined Study

- Deanna Archey introduced Darrell Smith, Project Manager with VBH who provided information and insight regarding Montgomery County's Ride-on Reimagined Study.

Report from Commission members who represent specific groups

- Commission Chair Ellis discussed her outreach to different groups that represent the general public, including the Bethesda Urban Partnership, the Metropolitan Washington Council of Governments, and the Wheaton Urban District Citizens Group.
